NATIONAL-LEVEL WEBINAR 'IMPACT OF CASTE SYSTEM IN NEPAL'

On the auspicious occasion of FEDO's 28th Anniversary, FEDO organized a webinar under the topic "Impact of Caste system in Nepal" to broaden the concept as well as to clarify the concept that this conventional caste system has further complicated the lives in more complex ways.

In Nepal, the caste system appeared in the ancient era. The higher caste group holds the power and monopolizes the system. Therefore this structure has been badly impacting the lives of Dalits for ages, the power dynamics on different caste groups have been beholding the situation moreover, taking lead in the social, economic, and political strata ultimately resulting in not just discrimination towards the Dalit community but to the community of another caste group too.

So in this context, this webinar was organized across the nation by involving different concerned stakeholders, frontline leaders, and media personnel who presented their thoughts on the impact of the caste system that has been faced by a different section of the people.



